HEALTH & SAFETY AT EVENTS IN 2012

There are specific H&S requirements which are applicable to BE Events and some other activities and venues, whether you are trading or providing a service. Based on your insurance validity, you will be allocated an approval number, which expires with your cover, once you have submitted the evidence requested below. This scheme entails your records to be held centrally so that, at activities with which I have a connection, the same number can be quoted without our having to hassle you on the ground.

Please complete the 'pink' H&S declaration attached and return it to me, together with copies of the relevant insurance documents **which undisputedly show the validity dates and that they refer to your business.** (You can use the fax if that is more convenient). An approval number will be allocated once the correct documents are received. Tradestands will still be liable to produce them to any H&S Enforcement Officer that visits the event so **they must** accompany you.

For traders who do not have adequate insurance yet, I have summarised 3 of the cheaper options below. These brokers have been a welcome find for many of you, I am told, but you should obviously carry out your own research: Combined Market Traders' Insurance Association - Harry de Costa; National Market Traders' Federation; Marketinsure Starter - Mr Imber
